## **CAUTION, USE& LIABILITY**

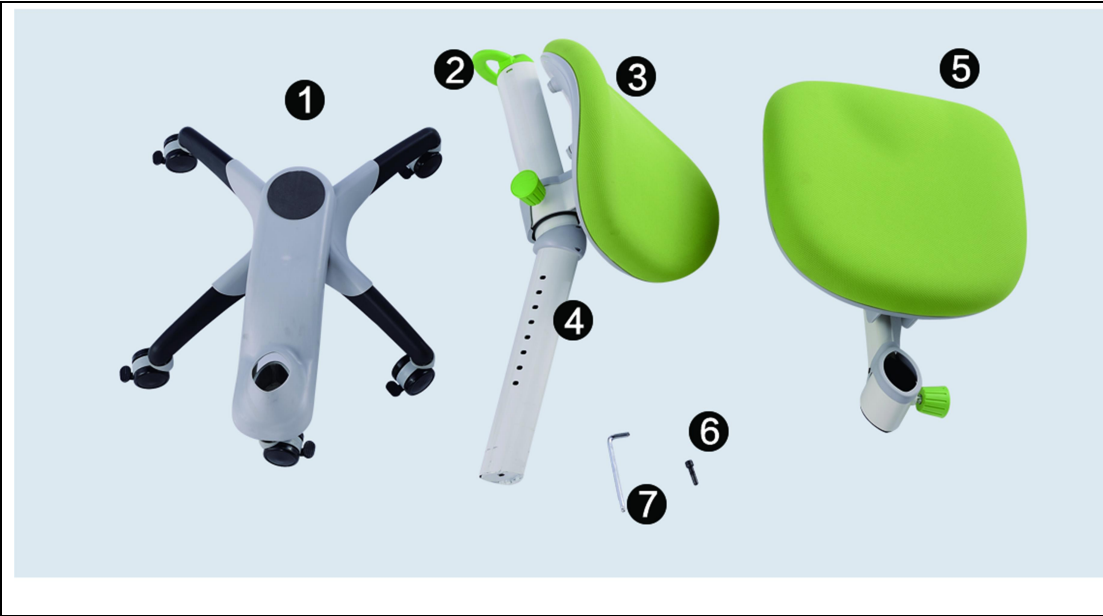


**Keeps small items away from small children. Keep hands off pinch points.**

## ASSEMBLY INSTRUCTIONS

### STEP 1

Slide in backrest and insert the plastic piece



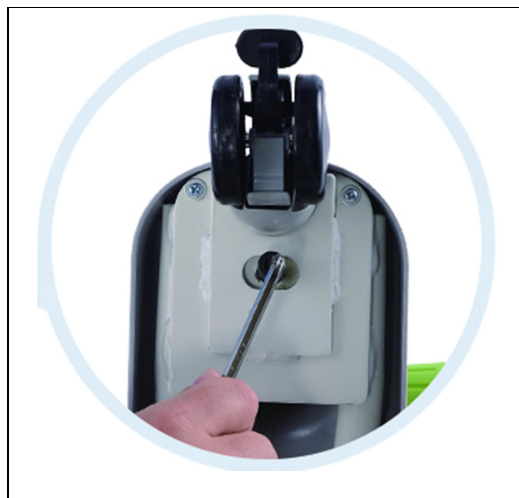
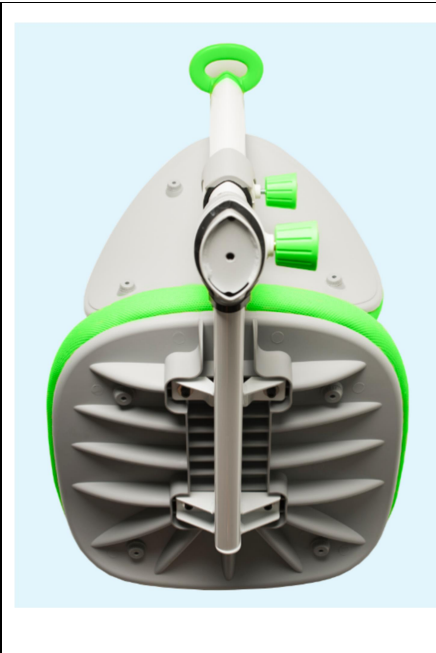
### STEP 2

Insert assembled backrest from Step 1 into the seat ring. Move the seat up and half-tighten it by turning the knob clockwise.

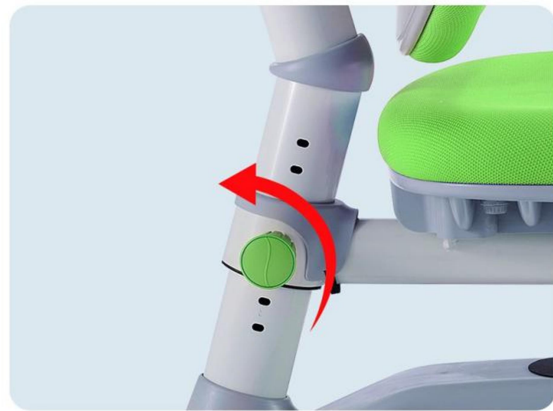


### STEP 3

Turn the assembled chair from Step 1 thru 2 over. Insert the base with casters upside down. Align the mounting hole on the backrest rod with that of base. Secure it with the screw.



**STEP 4: Turn the chair back onto its casters. Turn the knob counterclockwise to make adjustment to the backrest height and seat height.**

**Chair is designed to swivel 15 degree left and right when casters are locked**
